

ARTICULATION AGREEMENT

For Business Administration

Between
Danville Community College (DCC)
And
Virginia Commonwealth University (VCU)

For students planning to pursue Accounting, Business Administration and Management, Economics, Finance, Human Resource Management, Marketing and Real Estate at VCU

Purpose: This articulation agreement has been developed within the framework of the Virginia State Policy on Transfer to facilitate the transfer of credits earned by students with the Associate of Arts & Science (AA&S) Degree in Business Administration credits at Danville Community College into Bachelor of Science (B.S.) degree programs in Business at Virginia Commonwealth University. It is intended to provide students enrolled in the Business Administration AA&S program at Danville Community College admission into the baccalaureate business programs (with the exception of Financial Technology and Information Systems) at Virginia Commonwealth University. This agreement establishes a partnership between DCC and VCU for the benefit of students.

DCC will advertise this program to the general public within the DCC service area. The program will be promoted as the "Business Administration Associate of Arts & Science Transfer Degree Program" in the DCC catalog, registration schedules of classes and other promotional materials. Representatives of DCC and VCU will call attention to this articulation agreement when advising students.

Students who intend to transfer to VCU under the terms of this agreement must complete the **Letter of Interest** after completing 15 credits at DCC and send it to the Office of Undergraduate Admissions, Virginia Commonwealth University, 821 West Franklin Street, P.O. Box 842526, Richmond, VA, 23284-2526 (http://www.ugrad.vcu.edu/admissions101/transfer/VCCS-VCU_Interest_in_Transferring_Form.pdf). Students who complete the **Letter of Interest** will be contacted periodically by VCU representatives with important information to ensure a successful transfer to VCU.

Courses listed in this program will be reviewed, as needed, by faculty of both institutions to ensure continuity of instruction and curriculum. A formal evaluation of the agreement will occur every three years for purposes of (1) monitoring and enhancing student

academic success and (2) evaluating the effectiveness of this agreement. The attached "Business Administration Transfer Program Table" lists the respective transfer credits that will be awarded by VCU for courses offered by DCC for transfer. This table will be updated as curricula evolve. There is a limit of 66 credits that may be transferred from DCC to VCU and course equivalency and transfer credits should be limited to those courses required for the student's selected major.

VCU School of Business will guarantee admission into its B.S. programs with junior standing (Accounting, Business Administration and Management, Economics, Finance, Human Resource Management, Marketing and Real Estate) those students in the DCC transfer option who have completed the Associate Degree in Business Administration and who have a minimum curriculum grade point average of 2.50 on a 4.0 scale and no individual course grade lower than "C."


VCU will consider admission into its B.S. Business Foundation program DCC curricular Business Administration AA&S program students who have not completed the AA&S program. However, VCU highly recommends that students earn at least 30 credits prior to transfer.

Transfer may occur at any time during the above-prescribed course of study at DCC. However, the course equivalencies as stated in the Business Administration Transfer Program Table are based on the completion of the Business Administration AA&S degree program prior to transfer. Students who transfer prior to the completion of the Business Administration AA&S degree program will have their courses evaluated individually per the VCU Transfer Guide. Therefore, students are encouraged to complete the Business Administration AA&S degree prior to matriculating to VCU.


Students can transfer credits back to DCC from VCU.
